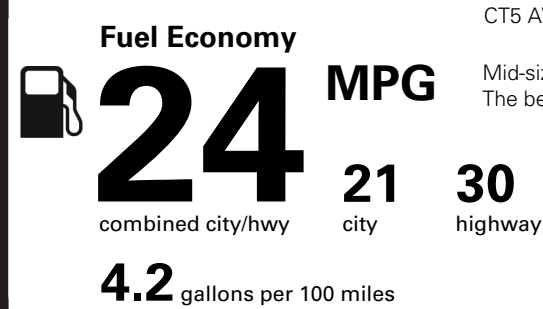

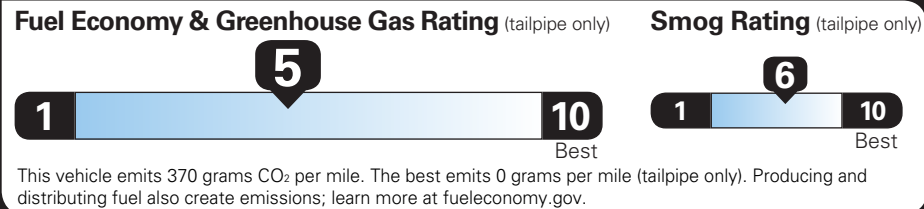
Gasoline Vehicle
